

Federal highways:

M5 Ural (Moscow - Samara - Chelyabinsk), federal highway distance -1879 km. This highway is a part of Euro route network (highway E30) and Asian Euro route network (highway AH6).

M6 Kaspij (Moscow – Volgograd – Astrahan). federal highway Moscow – Volgograd – Astrahan. distance — 1381 km. This highway is a part of of Euro route network (highway E119) and Asian Euro route network (highway AH8). Part oh highway from Volgograd to Astrahan is also part of Euro route network(highway E40).

Roads of regional sub ordinance:

P123 regional sub ordinance highway: "Spas-Klepiki — Ryazan". Route begins from highway crossing regional highway P105 "Moscow — Egor'evsk — Kasimov", near Spas-Klepiki town. The road trends from the North to the South of Ryazan district through the territories of Ryazan and Klepikov regions, without crossing with any big traffic roads. It is also crossing "Pra" and "Oka" Rivers. It is finishing at the crossing with federal highway M5 »Ural» near Ryazan city.



Service facility building №34: Total area 9162 sam






Heating boiler-welding house -workshop №24: Total area 14986 sam




Production area and administrative buildings, small-scale Workshops:
